On 9/8/2013 at approximately 2:30am, I responded to 9 Fenimore Ln, Palm Coast, in reference to a delayed residential burglary. Upon arrival I made contact with Sabine Kurz (victim) who stated that someone broke into her residence and stole multiple items.

Sabine stated that on 8/30/2013 at approximately 4pm, she left her residence to go on vacation and returned on 9/8/2013 at approximately 2am. Sabine stated that when she made entry into her residence she noticed a wooden box that was sitting in a living room cabinet prior to her going on vacation, was now sitting on her dining room table with all the items dumped out. Sabine stated that she started looking around the residence and noticed multiple cabinet and closet doors pulled open. Sabine stated that she went into her bedroom and noticed all her dresser drawers were pulled open, her clothing and other items were rummaged through and thrown about. Sabine advised she then decided to call 911. Sabine stated that she locked the residence prior to her leaving for vacation, but when she returned, she found the back sliding glass door unlocked.

I also made contact with Daniela Apfelbach, Sabine's daughter who was also on scene, who stated that she came to the residence on 9/7/2013 at approximately 4:00pm to drop items off inside the residence and she did not see anything out of the ordinary or did not notice anything rummaged through.

I was unable to observe any fresh pry marks on the back slider or front door and was unable to locate any open or unlocked windows. After making entry into the residence I observed multiple closet doors and dresser drawers open and had been rummaged through. There was also multiple clothing and other items pulled out and thrown about from the dresser drawers in the master bedroom and bathroom. I dusted for latent prints on a box that was moved from the living room closet and was found lying on the dining room table, but was met with negative results. I also tried to pull latent prints from the bathroom glass cabinet door that was found open and the bathroom cabinet doors that were pulled open, but was met with negative results. Multiple gold in color jewelry was found missing from the master bedroom. It looks as if entry was made through the unlocked back sliding door.

Estimated cost of the items missing is \$6906.00 dollars.

On 9/8/2013 at approximately 5:50pm, I conducted a follow up with Sabine and an area canvass. I was met with negative results on the area canvass. There is no description of the subject at this time. Sabine provided me with an inventory sheet of the items found missing. Refer to inventory sheet for information on the items missing. Sabine also provided a written statement; I provided her with a case card and advised her if she finds out any further information to call the Sheriff's Office.

There is nothing further to report at this time.
